SERVICES

I. Master Class: _____
Date Timeframe Venue/Location

James R. Wigginton will present a 2 to 3 hour class (at the client's discretion), wherein he will thoroughly explain the mechanics of vocal technique, performance and style. The fee for this Master Class is \$500. The class time shall be divided thus: 1st half focusing of technique and 2nd half focusing on application of technique to style and performance. The contents of this class are flexible as to **CLIENT**'s particular needs.

II. Private Sessions: _____
Date Timeframe Venue/Location

James R. Wigginton will be available to administer private sessions. Private session fee is \$150; session will be 50 minutes in length. Participants can reserve ahead by contacting our Nashville studio directly (via email or phone), or they can sign up for any remaining times at the Master Class. Mr. Wigginton will perform up to (10) private sessions during this day. All sessions will be recorded on CD for each singer (*this is provided by Mr. Wigginton*). **DUE TO THE LIMITED NUMBER OF SPOTS, ALL PRIVATE SESSIONS MUST BE PAID IN FULL BY THE END OF THE MASTER CLASS (THE EVENING BEFORE PRIVATE SESSIONS BEGIN). THIS IS NECESSARY TO PREVENT "NO-SHOWS" AND WASTED SESSIONS.**

III. Additional Services

James R. Wigginton is in no way obligated to grant private audience to individuals. Questions will only be addressed in a public forum so that the entire class may benefit. Those wishing to discuss careers, music industry, or anything else in a private setting may schedule such a time during the Private Session day.

If the CLIENT would like to request additional specific services, an agreement between both parties shall be documented separate from THIS contract.

PAYMENT SCHEDULE

Deposit Due Date

Private Sessions: All session fees (\$150/50mins) must be collected by the end of the Master Class. This has become necessary to eliminate “no-shows” and wasted sessions.
